

REGULATIONS DRIVING DAYS | 2024

Art. 1º – ORGANIZATION

- 1.1 – The organization of Driving Days is the responsibility of A.S. Marques – Motor Sponsor Unipessoal Lda. (hereinafter referred to as the "Organizer" or "Organization").
- 1.2 – The organization, duly authorized by the Portuguese Federation of Automobilmism and Karting (FPAK), organizes a reserved sporting event, non-competitive in nature, called "Driving Days".
- 1.3 – All drivers/pilots of Driving **Days** must mandatorily hold an FPAK Leisure License or higher. This license for participation in the Driving Days event will provide its holders with personal accident insurance coverage, valid within national territory. The conditions of the insurance taken out can be consulted at www.fpak.pt.
- 1.4 – Participants of Driving Days must request the issuance of the Annual FPAK Leisure License from FPAK, the annual fee for which is set at 35 euros + mandatory insurance, or a higher license.
- 1.5 – If they do not hold the Annual FPAK Leisure License or higher, Driving Days participants can request the issuance of a Single FPAK Leisure License during the event weekend from the organization. This license will be valid only for the event in question, and the organization is responsible for registering each participant on the FPAK website, with a cost of 10 euros.
- 1.6 – No responsibility can be claimed or demanded from the organization or its sponsors and partners for any personal or material injuries, including the vehicle used, that any participant may suffer.
- 1.7 – Cases not provided for in these regulations, as well as all doubts arising from their interpretation, will be analyzed and decided by the Driving Days Organizing Committee.

- 2.2 – The organization reserves the right to modify this schedule by substituting, canceling, nullifying, or changing the dates of the events.

Art. 3º – REGISTRATION

- 3.1 – Registration for Driving Days is done exclusively through the website www.motorsponsor.pt.
- 3.2 – Registration will only be accepted upon the provision of all requested information and after successful payment.
- 3.3 – Once the information referred to in article 3.2 is received, the confirmation of registration will be communicated to the participant.

Art. 4º – FORMAT

- 4.1 – At Driving Days, participants will have access to the open track during both the morning and afternoon sessions.
- 4.2 – Included in Driving Days is the Driving Days Club, a private event where all types of vehicles are allowed, including competition vehicles and vehicles in the development phase for competition.
- 4.3 – Also part of Driving Days and Driving Days Club is the Estoril Shakedown, an exclusive category for competition vehicles and vehicles in the development phase for competition.
- 4.4 – All vehicles must be in good condition and well-maintained to ensure they do not endanger

the participation of other attendees.

4.5 – To ensure the highest possible safety, any registered vehicle may be subjected to a technical inspection by the organization on the day of the event.

Art. 5º – REGULATION

5.1 – By registering, the participant confirms that they accept the regulations and briefing associated with the Driving Days.

5.2 – It is mandatory, and each participant is responsible for complying with the Driving Days regulations outlined in ANNEX I of these regulations.

Art. 6º – BRIEFING

6.1 – It is mandatory for all participants to attend the briefing; only then will they receive the wristband that allows them to enter the track.

6.2 – Failure to attend the theoretical briefing will require the participant to attend a video briefing instead.

Art. 7º – TRACK ADMISSION

7.1 – In Driving Days and Driving Days Club, both classic and modern vehicles are allowed.

7.2 – Minivans, SUVs, motorhomes, and vehicles with fewer than four wheels are not permitted in Driving Days and Driving Days Club.

7.3 – In the Estoril Shakedown, competition vehicles as well as vehicles in the project phase for competition are allowed.

7.4 – The minimum age for each passenger/co-driver (limited to 1 per car) is 18 years old.
